## **CLUB REGISTRATION PROCEDURE**

1. A Club wishing to become a Member of the South Australian Veterans Cricket Association (“SAVCA”) and to enter one or more teams into any SAVCA competition should first meet with relevant representatives of the SAVCA Committee to discuss the Club’s intention to register teams for one or more SAVCA competitions. A Club may apply to enter as many teams into SAVCA competitions as that Club may think fit.
2. A Club applying to enter one or more teams into any of the SAVCA Over-50’s, Over-60’s and Over 70s competitions must be able to provide, at its own cost, one playing oval per team for all home games, along with all necessary match-day equipment. All ovals must have a turf wicket. To facilitate the scheduling of games, one playing oval per team must be available on Sundays throughout the season i.e. from the 1st of October through to the 31st of March in the following year. All grounds should have adequate changing and showering facilities as well as both male and female toilets.
3. To apply to become a Member of SAVCA, a new Club must submit a written application using the form at the end of this document. Completed forms should be sent by e-mail to [secretary@savca.com.au](mailto:secretary@savca.com.au), confirming that:
  - a. the Club is an existing Senior Club or is affiliated with an existing Senior Club
  - b. the Club is Incorporated
  - c. the Club supports the purposes of SAVCA and wishes to become a Member of SAVCA
  - d. the Club and its officers, members and players agree to be bound by the SAVCA Constitution, Rules and By-Laws, and will accept all reasonable and relevant decisions made by the SAVCA Committee
  - e. the Club will be appropriately insured, at its own cost, for the full duration of the season (e.g. under the Cricket Australia National Risk Protection Program)
  - f. the Club agrees to pay an annual membership fee per team upon acceptance, as determined by SAVCA and to be advised to all clubs prior to the start of the season.
4. The Application must:
  - a. Be submitted no later than the 30th June immediately prior to the commencement of the season.
  - b. Be accompanied by payment of a non-refundable application fee (currently \$100 per team). For each team, SAVCA will offset the fee against the first year of the Club’s membership fees if the Club’s application is accepted. An application will not be considered until the application fee has been paid.
  - c. State the number of teams that the Club wishes to enter into SAVCA competitions, and whether each team will be competing at Over-50’s, Over-60’s or Over 70s level
  - d. List the full name and address of the home ground(s) for each Team
  - e. Include a high-resolution image of the Club Logo
  - f. List the name and contact details of the Club’s President, Secretary, Treasurer and PlayHQ manager

- g. Be signed by the President and Secretary (or other office-holders) of the Club seeking Membership of SAVCA.
5. When assessing an application for Membership by a new Club, SAVCA will consider the impact of the application on the likely viability of existing SAVCA Clubs and on the competition(s) into which the Club is seeking to enter one or more teams. If a Club applies to enter more than one team, the application for each team will be considered separately. Assessment criteria will include (but may not be limited to) the location of the new Club and the proximity of the new Club's grounds to the facilities used by existing SAVCA Member Clubs. SAVCA may, at its sole discretion, accept or reject any application. SAVCA will make reasonable efforts to discuss and address any issues with the new Club prior to rejecting an application.
  6. Membership fees are payable to SAVCA solely as a contribution towards the expenses incurred by SAVCA in managing its competitions over the course of the season for which the fees are paid. It is the responsibility of each club to provide insurance, pitches and all necessary playing equipment, including SAVCA-approved match balls, which must be purchased at cost from the Association, for each of the Club's teams.
  7. SAVCA requires all Clubs to have a defibrillator and first aid equipment readily available at all home matches.
